**About our Organization** 

The Pacific Rim School District covers much of Central Vancouver Island's rugged, picturesque West Coast and serves a regional population of approximately 31,000 residing on the hahoulthee of the cisaa?ath, hupacasath, Tla-o-qui-aht, Yuulu?il?ath, and Huu-ay-aht First Nations within the communities Port Alberni, Tofino, Ucluelet and Bamfield. Our district respectfully acknowledges that we work alongside all Nuu-chah-nulth Nations as well as the Nuu Chah Nulth Tribal Council, the Alberni Clayoquot Métis Society, and the Port Alberni Friendship Center to serve the children and youth of the Alberni-Clayoquot region.

Our district learning facilities include eight K-7 elementary schools, two 8-12 secondary schools, one K-12 school, one Alternate Education Learning Centre and one Continuing Education Centre serving approximately 4,200 students including school aged and adult learners. In addition, our district's Pacific Rim Children and Families programs include a Family Hub, four StrongStart programs, and growing childcare programs. The school district employs close to 500 employees and has a 2022/2023 overall budget of nearly \$45 million. Our Indigenous student population is approximately 36%.

Relative to provincial and regional socio-economic indicators, risk factors that impact our communities include a higher unemployment rate, lower levels of education, lower median income, and higher rates of lone-parent families. Specifically, for our Indigenous families, our region sees first-hand the effects of residential schools and the intergenerational trauma results. Thus, the social, emotional, and economic impact on families and learners, specifically behaviour, attitude and thinking, presents itself daily in schools across the district.

The Board of Education of Pacific Rim School District recognizes the diversity of our school district and classrooms strengthens learning opportunities, fosters learning environments, and values the contributions of all members of our school communities.

This recognition and awareness inspired the school district to develop policies in 2022-2023 formalizing the recognition of diversity through policies on Inclusion, Diversity and Equity, Accessibility, Non-Discrimination, Anti-Racism, Newcomers, and Multiculturism. By formalizing our beliefs and celebration of diversity in our schools and communities, the school district understands our actions of recognition are as important as the policy development.

Pacific Rim School District is situated on Nuu-chah-nulth territory and communities and is gifted with rich Nuu-chah-nulth culture and traditions. In this landscape, through learning Nuu-chah-nulth ways and relationship building, the school district continues to deepen an understanding of the accessibility barriers resulting from the historical and intergenerational trauma of residential schools.

The Accessible BC Act adopted in 2021 is the catalyst and guide Pacific Rim School District needed to move forward. This Accessibility Plan conveys our commitment to walk this path of deepening our understanding and improving accessibility to learning, growing and connection with students, families and our communities.



# **Definitions Important to Know**

**Disability:** The state of being unable to participate fully and equally in society as a result of the interaction between an impairment and a barrier.

Impairment: A physical, sensory, mental, intellectual, cognitive limitation, whether permanent, temporary or episodic.

**Inclusion:** "An attitude and approach that embraces diversity and differences and promotes equal opportunities for all. Inclusion is not just about people with disabilities. When our communities include and embrace everyone, we are ALL better able to reach our full potential." - Inclusion BC

**Accessibility:** The state of having programs, services and environments that allow all individuals to participate fully in society without encountering barriers.

**Barrier:** Anything that prevents a person with a disability from fully participating in all aspects of society because of their disability. This includes architectural, attitudinal, information, communications, policy or practice, and technological barriers.

# **Examples of Disabilities**

**Mental health disability:** examples are major depressive disorder, anxiety disorders, post-traumatic stress disorder, substance addiction, dysfunctions resulting from historical and intergenerational trauma caused by residential schools

**Physical disability:** Paraplegia, multiple sclerosis, cancer, epilepsy, diabetes

Sensory disability: Hearing loss, vision loss

Neurodevelopmental: Autism Spectrum Disorder, ADHD,

Intellectual disability

Learning disorder: Dyslexia

Cognitive impairment: Brain injury, stroke or dementia



# **Existing Policy**

SD70 Accessibility Policy: (P:XXX)

The Board of Education of School District 70 Pacific Rim recognizes the diversity of our School District and classrooms strengthens learning opportunities and fosters learning environments that value the contributions of all members of our school communities.

The Board of Education further identifies accessibility, in addition to inclusion, as a core value and supports the principle of accessibility in all aspects of the district's sites, educational programs, classrooms, schools, and community interactions. The values evident in the principle of accessibility honors diversity, equity, safety, and an individual's right to have made accessible to them the school district, school environment, and learning opportunities.

This policy captures protected grounds covered by the <u>Accessible British</u>

<u>Columbia Act</u>, the <u>Order of the Lieutenant Governor in Council Number 218</u>, the <u>Human Rights Code of BC</u> and is intended to ensure that all employees, regardless of their personal beliefs, reflect on how their actions and interactions create an accessible, respectful, safe and supportive environment for all members of our school communities. Therefore, the Board of Education expects the principles of accessibility are reflected in the creation of the following:

# Initial Focus of District Accessibility Advisory Team

To increase familiarity with the Accessibility BC Act, School District Pacific Rim policy, to explore and refine the scope and purpose of the advisory team within the school district, to finalize Terms of Reference, and explore ways to seek volunteers more the District Accessibility Advisory Team.

#### Recruitment

The District Accessibility Advisory Team was initiated by the Director of Inclusive Education, a high school and elementary administrator, and district counsellor. This small SD70 staff group reached out to parents and community members, along with select SD70 staff to make up the initial advisory team.

Recruitment for the Accessibility Advisory Team will be determined and activated within year one of this plan being adopted. The goal is to seek team members that represent the diverse abilities as prescribed by the Accessibility BC Act and that represent the diverse abilities composition found within the province.

#### **Section 5: Feedback Mechanism**

# **Feedback Mechanism Development**

- A feedback form was created for the individuals to complete and provide feedback on individual experience with accessibility in the school district. A link to the feedback form is provided on the School District 70 Pacific Rim website with a brief description about the feedback form's purpose and how this information will be processed.
- Feedback on the form will be initially screened to ensure personal information is removed from the feedback.
- The feedback information will be shared with the District Accessibility Advisory Team. This team will review this feedback and make recommendations/suggestion/queries to the chair of the advisory team to take back to the school district. These recommendations/suggestion/queries will be then brought to the Accessibility Working Group (to be created in September 2023) to review.
- The Accessibility Working Group will receive feedback and suggestions from the District Accessibility Advisory Team. With this information the Working Group will create potential actionable items that may be brought forward to the Senior Leadership to consult on viability and potential next steps. This information will be brought back to the District Accessibility Advisory Team through the Working Group, with potential options.

# **Section 7: Monitoring and Evaluation**

### Monitoring

A monitoring report will be produced by the Director of Instruction for Inclusive Education on an annual basis and will be delivered at the [first accessibility committee meeting of the school year]. This review will include consultation with the District Accessibility Advisory Team and the Indigenous Education Advisory Team. The goals set out for Pacific Rim School District are embedded in the SD70 Operational Plan and aligned with the Pacific Rim School District Strategic Plan. This accessibility plan is reviewed throughout the year with an annual review to be reported to Pacific Rim Board of Education annually.

# **Evaluating**

In the annual review conducted by the Director of Instruction for Inclusive Education, an evaluation of the accessibility action items and goals will take place. The outcomes of the evaluation will influence any amendments to the Operational Plan. This review will be shared with the District Accessibility Advisory Team annually to inform and seek advice for future actionable items.

On September 1st (every three years from its date of adoption) School District 70 Pacific Rim will make public, the updated Pacific Rim School District Accessibility Plan. The approved Accessibility Plan will be made public by October 1st of the same year.
