6.2 District Strategic Plan

The multi-year plan focuses on improving numeracy, literacy, and well-being of students, and considers a variety of Ministry-, District-, and classroom-based indicators of student performance. Some of the data is already on the Ministry website, some it on the district Sharepoint site, other data to be collected at the end of the month. We are constantly looking at available data and look forward to having all of it ready to review as part of the ongoing consultation process.

What is notable in current 2021/22 data available from <u>B.C. Education System</u>

<u>Performance - Pacific Rim School District (gov.bc.ca)</u> is there remains concerns about gaps in performance between populations of students, particularly between Indigenous and non-Indigenous, and between learners on reserve and off reserve. Numeracy remains a primary consideration, as does the state of students' wellbeing and health. Yet students still express schools are safe, welcoming places where they are well-connected to adults, even if some students might struggle academically or find it difficult at times to have a sense of belonging.

The story is not unique to SD70, however, and in many of the results SD70 performance falls within the middle 50% of districts across the province. In other words, equity issues, numeracy issues, health and well-being issues are commonplace, and SD70 falls into the large middle of the province. Not that we aspire to average, but rather we are not alone when it comes to addressing some of our challenges. What might be remarkable is that our challenges are not more severe given the recent struggles of attendance and engagement.

We have shared data with the Education Committee of the Whole and will be gathering feedback from a variety of sources between now and September 30, 2022. The feedback process will focus on the strategies necessary to see improvement in these critical areas.

6.4 2022/23 Annual Budget Bylaw

ANNUAL BUDGET BYLAW

A Bylaw of THE BOARD OF EDUCATION OF SCHOOL DISTRICT NO. 70 (PACIFIC RIM) (called the "Board") to adopt the Annual Budget of the Board for the fiscal year 2022/2023 pursuant to section 113 of the School Act, R.S.B.C., 1996, c. 412 as amended from time to time (called the "Act").

- 1. Board has complied with the provisions of the *Act* respecting the annual budget adopted by this bylaw.
- 1. This bylaw may be cited as School District No.70(PACIFIC RIM) Annual Budget Bylaw for fiscal year 2022/2023.
- 3. The attached Statement 2 showing the estimated revenue and expense for the 2022/2023 fiscal year and the total budget bylaw amount of \$54,514,476 for the 2022/2023 fiscal year was prepared in accordance with the *Act*.
- 4. Statement 2, 4 and Schedules 2 to 4 are adopted as the Annual Budget of the Board for the fiscal year 2022/2023.

6.5 Election Bylaw 3-1

A bylaw to provide for the determination of various procedures for the conduct of general school elections and other trustee elections.

Preamble:

Under the *School Act*, a board of education may, by bylaw, determine various procedures and requirements to be applied in the conduct of trustee elections.

In the Pacific Rim School District, trustee elections are held in the following trustee electoral areas:

The Pacific Rim Board of Education wishes to establish various procedures and requirements under the authority of the *School Act* for trustee elections.

The Pacific Rim Board of Education in an open meeting of the Board, enacts as follows:

1. Definitions

The terms used in this bylaw shall have the meanings assigned by the School Act, the Local Government Act, and the Local Elections Campaign Financing Act, except as the context indicates otherwise.

"Board" means the Pacific Rim Board of Education.

"by-election" means a trustee election to fill a vacancy on the Board in any of the circumstances described in section 36 of the *School Act*.

"election" means a trustee election.

"general voting day" means the date on which general voting for a trustee election is to take place, whether part of the general school elections or a by-election.

"Minister" means the Minister of Education.

"Municipality" means the City of Port Alberni, District of Tofino and District of Ucluelet

"Regional District" means the Regional District of Alberni-Clayoquot.

2. Application

(a) This bylaw applies to both general school elections and by-elections, except as otherwise indicated in this bylaw.

3. Order of Names on the Ballot

The order of names of candidates on the ballot will be determined by lot.

4. Resolution of Tie Vote after Judicial Recount

In the event of a tie vote after a judicial recount, the tie vote will be resolved by lot in accordance with the *Local Government Act*.

5. Nomination Deposit

No nomination deposit is required for nomination for the office of school trustee.

6. Number of Nominators

The minimum numbers of qualified nominators for a trustee candidate in Trustee Electoral Area #1 is two. The minimum numbers of qualified nominators for a trustee candidate in Trustee Electoral Area #2 is two.

7. Application of Local Government Bylaws

If the Regional District or a municipality conducts all or a part of the trustee election, the elections bylaws of the Regional District and Municipality, as they may be amended from time to time, apply to that trustee election or part of the trustee election, except for any bylaws determining the minimum number of nominators, the order of names on the ballot, the resolution of tie votes after judicial recount, requiring a nomination deposit, or any other matter on which the local government bylaws may not by law apply to a trustee election.

8. Title

This bylaw may be cited as 'Pacific Rim Board of Education Trustee Elections Bylaw No. 3-1."

9. Repeal

Pacific Rim School District Trustee Elections Bylaw No 3 is hereby repealed.

Reporting Order

Feedback process is complete, and government has released a new Reporting Order that comes into effect in the 2023/24 school year. The key elements relate to the frequency and timing of reporting, the use of common proficiency scales (K-9) and letter grades (10-12), and student self-assessment on Core Competencies and Goal Setting. It is essentially what was initially proposed with the notable exception being the continued use of letter grades in grades 10-12. The district will have the 2022/23 school year to implement the revised Reporting Order.
