Dear Mr. Smyth,

This letter is a further appeal to you and your Board to provide Assistance to students from your District travelling to Victoria to attend the 12<sup>th</sup> Annual Provincial Heritage Fair. You may recall the letter written to you on behalf of the BC Heritage Fairs Society and sent to you on March 18<sup>th</sup>, 2019. At that time, we were awaiting a further meeting with representatives of the Ministry of Education continuing discussions for provincial funding. Our last meeting with them on May 2<sup>nd</sup> was very disappointing! They have not offered funding support.

Our continued efforts to reach out for sponsorship and support to the corporate world has been moderately received. Appeals to government sources are as elusive as ever with agencies passing us on to others, etc. We are at critical cross roads. Without additional funding, BCHFS is faced with a serious decision for 2020. The concept of the Provincial Fair, bringing young people from all four corners of the province, the interior and the islands together is in jeopardy.

As mentioned previously, we gratefully acknowledge the exemplary support that your district has given the North Vancouver Island Regional Heritage Fair. Not all districts have members to work alongside the regional coordinator, to act as judges, to attend Opening Ceremonies, and provide TOC coverage. Ms. Shelley Harding has strong praise for the level of support the program has from your district. We do not want to jeopardize this support for the Regional Fair but find that we need to reach out to ask for further support for the Provincial Fair.

This year, the delegates along with their chaperone attending the Provincial Fair from Port Alberni are three grade five students, namely Carlene Suman, Sierra Scott, and Summer Eskola; all from Macquinna Elementary School.

Any contribution your office can provide toward the average cost of \$1,000/student attending the Fair would be greatly appreciated. I can provide an Invoice and receipt as required.

Again, thank you for considering this request. I look forward to your response.
