# Superintendent's Report January 14, 2020

#### **Supreme Court Case**

School District 70 (Alberni) has recently received the ruling of the Honourable Mr. Justice Thompson of the British Columbia Supreme Court dismissing a petition seeking a declaration that a smudging demonstration at an elementary school by an Indigenous elder interfered with the petitioner's religious freedoms and the religious freedoms of her children.

With one third of SD70 students self-declaring indigenous ancestry, it is important that we continue to deepen the awareness, appreciation and understanding of Indigenous culture for all students. Teaching students about indigenous culture, history, traditions and practices is part of our BC curriculum and the events in this case were designed to teach students about smudging by having them observe a smudging demonstration in a classroom.

The Honourable Mr. Justice Thompson stated:

[94] I conclude that these smudging and hoop dancing demonstrations were in no way — either by design or in their execution — an expression of the School District's beliefs or an expression of religious favouritism. Rather, the organization of these events reflected a gathering momentum to incorporate the teaching of Indigenous worldviews and perspectives. I accept the evidence ... that the smudging or anything that the Elder said could not be construed as trying to make someone else believe what the Elder believed — when the Elder spoke, she used words like "our tradition is" or "we believe." And, arranging for students to observe hoop dancing, even if the dancing is accompanied by an Indigenous prayer, cannot reasonably be interpreted as the School District professing, adopting, or promoting religious beliefs.

[95] ... The facts in this case do not permit any reasonable conclusion other than that that the School District and its representatives neither favoured nor hindered any particular religious belief and that the JHES events did not violate the state's duty of neutrality.

#### **Enrolment Projections**

Enrolment projections for 2020/21 school year suggest a modest increase of approximately 60 students from 2019/20, split equally between elementary and secondary-aged students. After the 2020/21 school year enrolment is projected to level off before decreasing in 2029.

On the West Coast, Ucluelet Secondary will continue to see larger incoming cohorts of Grade 8 students driving total population close to 300 students within the next 10 years. While UES enrolment is projected to level off within 10 years, Wickaninnish enrolment shows signs of increasing for the next 5 years before levelling off. District staff is already looking at WCS capacity and, utilizing avenues through both seismic mitigation and school capacity programs, exploring ways to increase WCS capacity both short and long term.

In the Alberni Valley there remains sufficient capacity across the one secondary school and six elementary schools to accommodate valley enrolment projections.

## School Registration 2020/21 School Year

Registrations for the 2020/21 school year start on Monday, February 3, 2020. Registration procedures are outlined in Board Policy 500 and its various Appendices relating to timelines, documentation and catchment areas.

As in previous years, were mindful of the tension between enrolment projections and catchment areas and know that out-of-catchment requests will not be entertained at all Valley elementary schools. At this time the only certainty is that AW Neill Elementary and EJ Dunn Elementary will again accept out-of-catchment requests.
