Superintendent's Report December 10, 2019

Supreme Court Case

A lot of attention has been paid to the Constitutional challenge that was heard in BC Supreme Court the week of November 18-22, 2019. The School District will continue to refrain from public comment until a decision is rendered other than to address a couple of lingering issues or questions in our community. First, we want to be clear that no student was cleansed or smudged. Instead, students in three classrooms observed an elder cleanse the three classrooms – an educational opportunity to learn more about Indigenous culture and traditions. Second, the petitioner's request of the school district and, ultimately of the Supreme court, would tacitly impose a definition of 'religion' on Indigenous spirituality and culture – something that the school district was not willing or able to do. This explains the reason for the issue to be in Supreme Court and why legal proceedings also included submissions from the BC Attorney-General and Nuu-chah-nulth Tribal Council. Finally, the cost of litigation was not borne by SD70.

EJD Weekly Assembly

Very pleased to experience an EJD Elementary Monday morning assembly on December 9th. The weekly assembly helps start the week in a good way: it builds positive school community, orients students to the week ahead, acknowledges individual students, and celebrates togetherness through the signing of We are Strong. Most impressive is the increasing role students play in the morning assembly and the opportunity for students to develop their personal, social and cultural competency.

January 31 Curriculum Implementation Day

District staff are working with the ADTU and NTC in planning for the January 31, 2020 Curriculum Implementation Day, the focus of which will be on Indigenous Education on SD70. Preliminary plans include a keynote session for all staff, followed by breakout sessions on specific topics with the afternoon reserved for schools to work on their school plans as they relate to Indigenous Education. The latter includes increasing academic success for Indigenous learners as well as increasing the understanding and awareness of all students of Indigenous culture, worldviews and perspectives.
